- No group activities planned due to current health crisis, however Meg has been working on another project reviewing Westgate Mall lease to lower rent costs for Intergroup.
 - o When Westgate Mall was sold, the new owners required AA to pay \$200 per month extra for liability insurance.
 - o Currently rent plus insurance is \$965/month or \$11,580 per year.
 - o Meg had lease reviewed by local Attorney who discovered that AA never received signed copy of lease, rendering lease invalid. Therefore, AA can terminate lease without penalty.

- o Several IG Committee members scouted out new locations and found best option to be Star of Bethlehem Church (where Mid-Day meets)
- o Potential new location is 525 sq. ft. for \$250/month + \$100/mo for insurance. Savings per year: \$7,380!
- o The room has windows, is beautiful. Locked & secure. Only used approx 10 hours per week, so Westgate office is going unused. Hotline now fully mobile, so landline not needed.
- ➤ If IG votes "yes", we can start moving Aug 15 for move-in date of 9/1. VOLUNTEERS will be greatly appreciated & needed to help move bookstore.
- > Please take this information to your group. Vote to move will be held at next IG meeting 7/28.
